## **OUTRIGHT 2022 CAMPAIGN ACTION**

For OutRight 2022, UNICEF UK would like to share children's views on their right to the best possible health and the importance of strong health systems with an important decision maker and their team at the Foreign, Commonwealth and Development Office (FCDO) of the UK Government.

## HOW WILL UNICEF UK DO THIS?

We've designed an activity for your group to **collectively create a piece of work** that demonstrates their learning and why they care about it this topic, **to campaign for children's right to the best possible health.** 

You will then be able to **scan** and **upload** the piece to a secure link so that UNICEF UK can collate the work from all the settings taking part in OutRight and share this with a minister and their team working on this topic at the **Foreign**, **Commonwealth and Development Office (FCDO) of the UK Government** to advocate

# The group's piece of work, which could take many forms, should communicate one or more of these themes:

- Why is children's right to the best possible health important to you?
- What does a strong healthcare system look like?
- What difference would it make to children around the world if they could access the healthcare they need, whenever they need it?
- How do strong health systems protect children's rights?

## As a group, here are some ideas of what they could create:

A poem, letter, poster, collage, comic strip, story with a rights respecting ending, snakes and ladders board (see Activity 4) or something else that they suggest!

## What will UNICEF UK do?

- We will share the submitted pieces of work with a minister at the FCDO and their team before the end of 2023. We'll keep you updated on this!
- We will request that the minister's office do not share the children and young people's work more widely.
- UNICEF UK will store this information on our secure server in a restricted access folder, until the end of December 2023.
- None of the children's information will be used for any other purpose than those outlined above without further permission.

## WHAT DO YOU NEED TO DO?

Please review the information above and decide whether you will run this activity with your group.

If you decide to go ahead, please make sure you:

- Share the letter we have sent to you with the parents/carers giving them an opportunity to review the activity, and to let you know if they would rather their child(ren) not take part. It's important they receive this letter and have enough time to let you know if they have concerns before the activity.
- Help children understand what we are trying to achieve with this activity, and what they may want to include in their work
- **Explain** to children and young people what UNICEF UK will do with their information, how we are protecting it, what they should avoid including in their message, and why.
- **Supervise** children when they are creating their work as appropriate to their age and evolving capacities.
- Review the work they create children and young people should not share any <u>special</u> <u>category data</u>, including about their own health, or further identifying details such as surname, date of birth, address, contact details etc. Once submitted, we will also screen for this.
- Scan the work (if it is produced offline) and convert it to a <u>high resolution PDF</u> format (there are free services online if you need). Please scan, and not photograph, the work – <u>it</u> <u>must be very clear and all readable</u>.
- Name the file with the form/group name, the organisation/school name and the date it is uploaded, e.g. "Form 4B, St Joseph's School, 16.12.22".
- **Upload** the pdf to our secure link which can be accessed <u>HERE</u>.
- If you would like to take part in this activity, please submit your group's piece by <u>17<sup>th</sup> March</u>

## **INFORMATION TO SHARE WITH CHILDREN AND YOUNG PEOPLE**

#### What do we mean by information?

- Your class or group name, e.g. Form 4B
- Your school/organisation's name
- The work your group create about health and children's rights

#### What information will we share with the Minister at FCDO and their team?

#### What should you not include?

Please do not share personal or private information like:

- Your name
- Your date of birth
- Your address
- Your contact details
- Any information about your own health

- We will ask them to not share the work with anyone else.
- We will store this information on our secure server in a restricted access folder, until the end of December 2023.
