ABOUT THE ROLE

This post will be responsible for building and managing partnerships with key institutional partners and prospects, including Jersey Overseas Aid, Greater London Authority, and the Isle of Man Government. The postholder will be a proactive fundraiser who can work at pace and is confident at developing new partnership opportunities and building networks.

What we will expect you to achieve

- Work with the Institutional Funding Lead to secure new partnerships with prospective statutory and institutional partners, prioritising strategic partnerships at the six and sevenfigure level.
- Support, and lead where requested, the development of new funding bids by coordinating
 with other teams to produce proposal narratives, programme budgets, communication
 plans and other information as needed.
- Be at the forefront of latest donor trends and support the Institutional Funding Lead to explore new and innovative sources of funding, where requested.
- Manage a personal portfolio of existing institutional and statutory partners giving primarily at the six-figure level.
- Provide excellent grant management with responsibility for ensuring donors receive highquality reports (narrative and financial), monitoring compliance with contracts, and effectively managing and communicating change to internal and external stakeholders.

- Retain and grow your caseload of existing partners by providing a consistently high level of donor stewardship, building strong relationships with partner focal points, and proactively exploring opportunities to grow and diversify partnerships.
- Work collaboratively with key internal stakeholders, including UNICEF's Country Offices, Regional Offices, and teams at UUK, to effectively manage all relevant internal processes (e.g. risk screening, fund transfers, legal agreements etc).
