GIFT AID

You can make your donation worth a quarter more. For every £1 you donate, we can claim an extra 25p from HM Revenue and Customs if you give us permission to claim Gift Aid on your donations. This means your kind donations will be worth an extra 25% to us, enabling us to do 25% more for children without costing you a penny more! Gift Aid will be used to help fund the whole of UNICEF's work.
